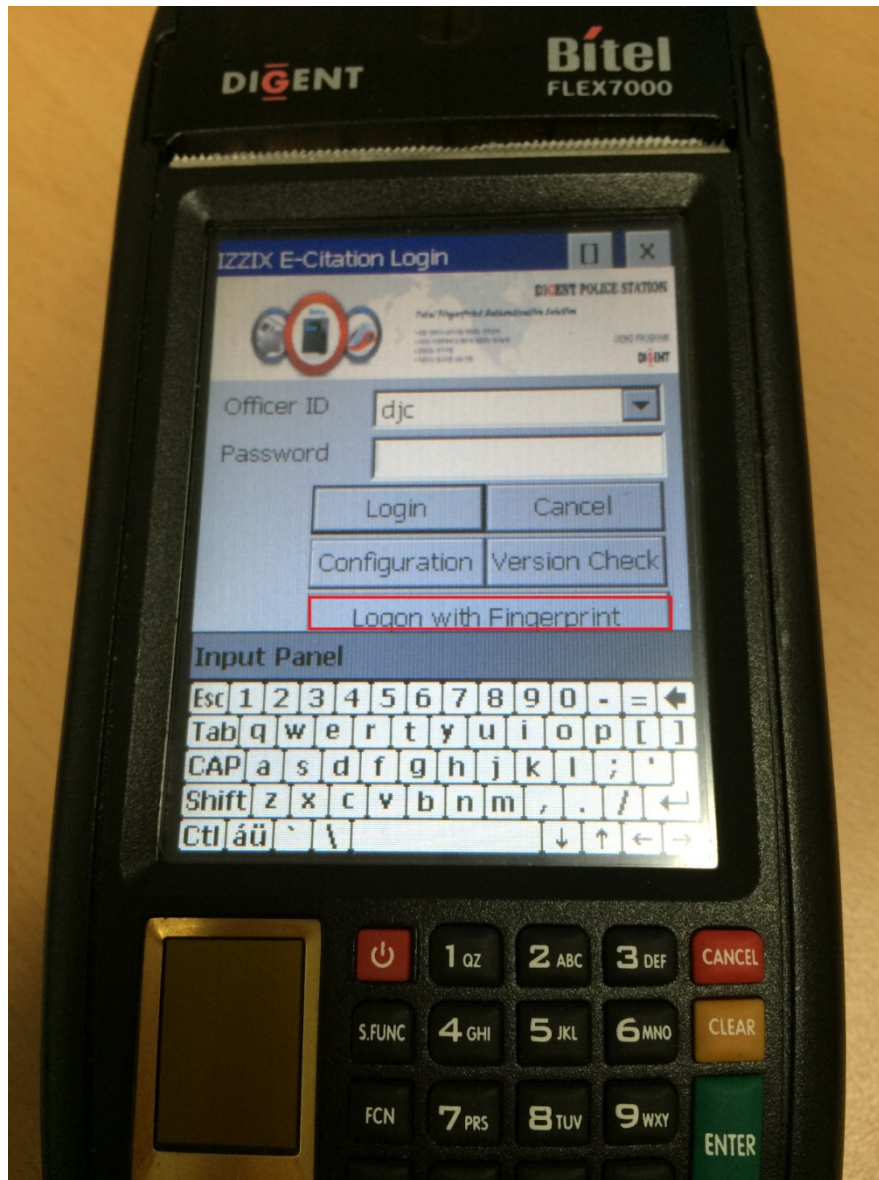
This screen is initial E-Citation program



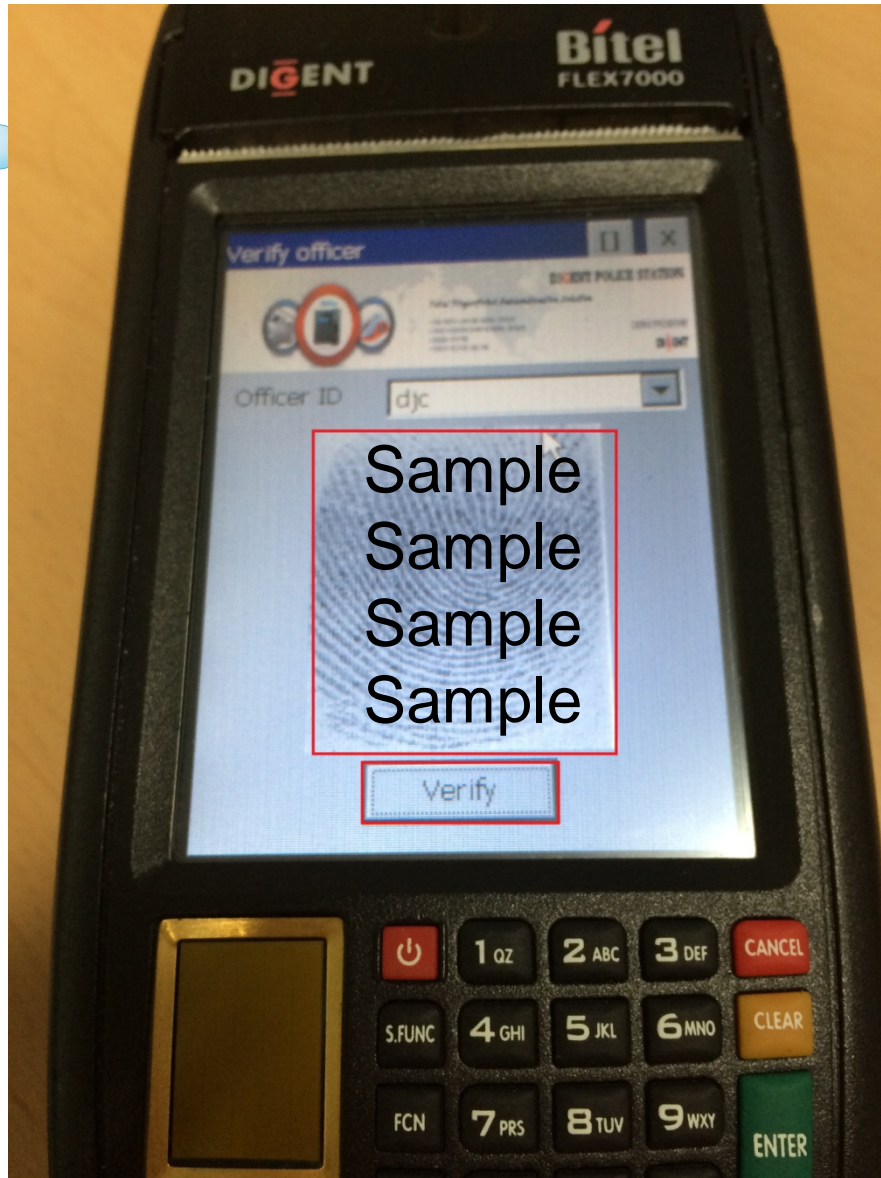
1. Input Password



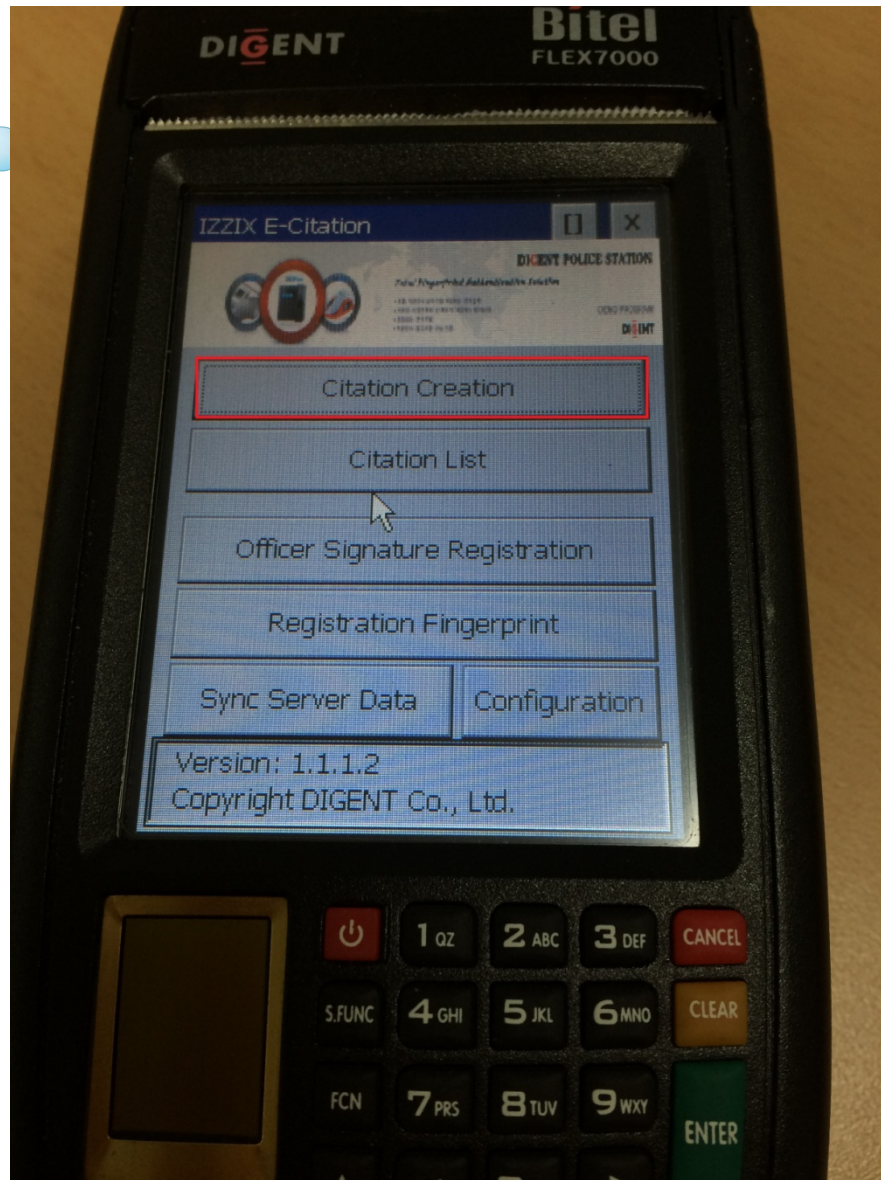
2. Press Button [Login]



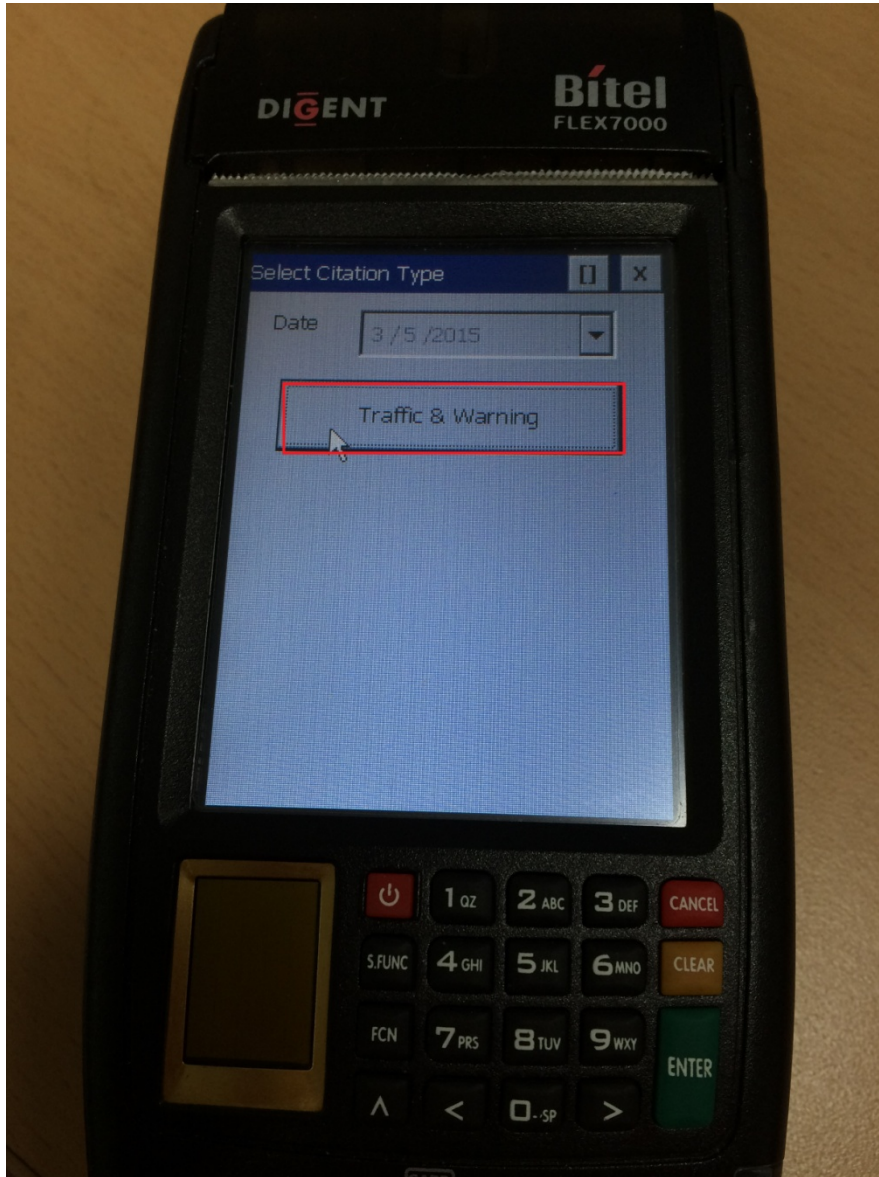
1. Press Button [Logon with Fingerprint] for logging on with fingerprint



2. Scan fingerprint by using fingerprint sensor attached on the device



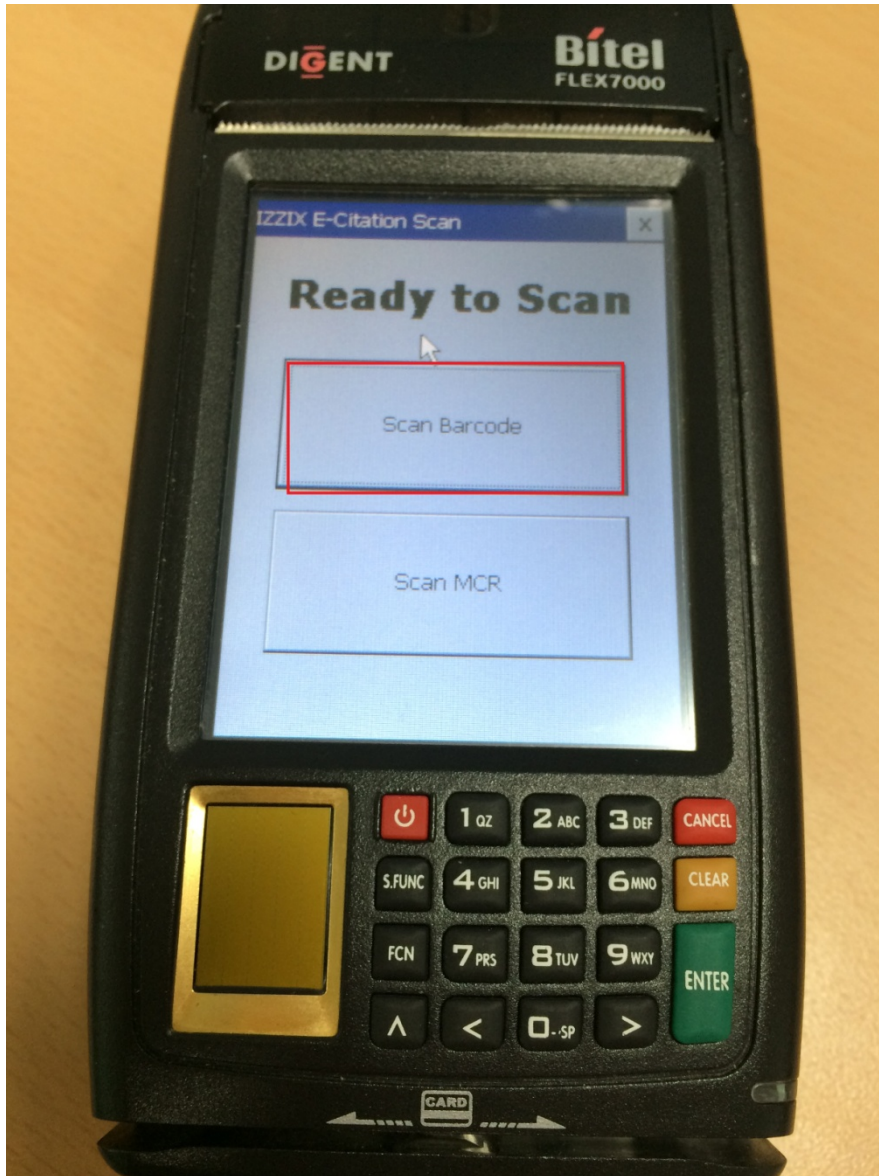
3. After logging on, Press Button [Citation Creation] for issuing citation



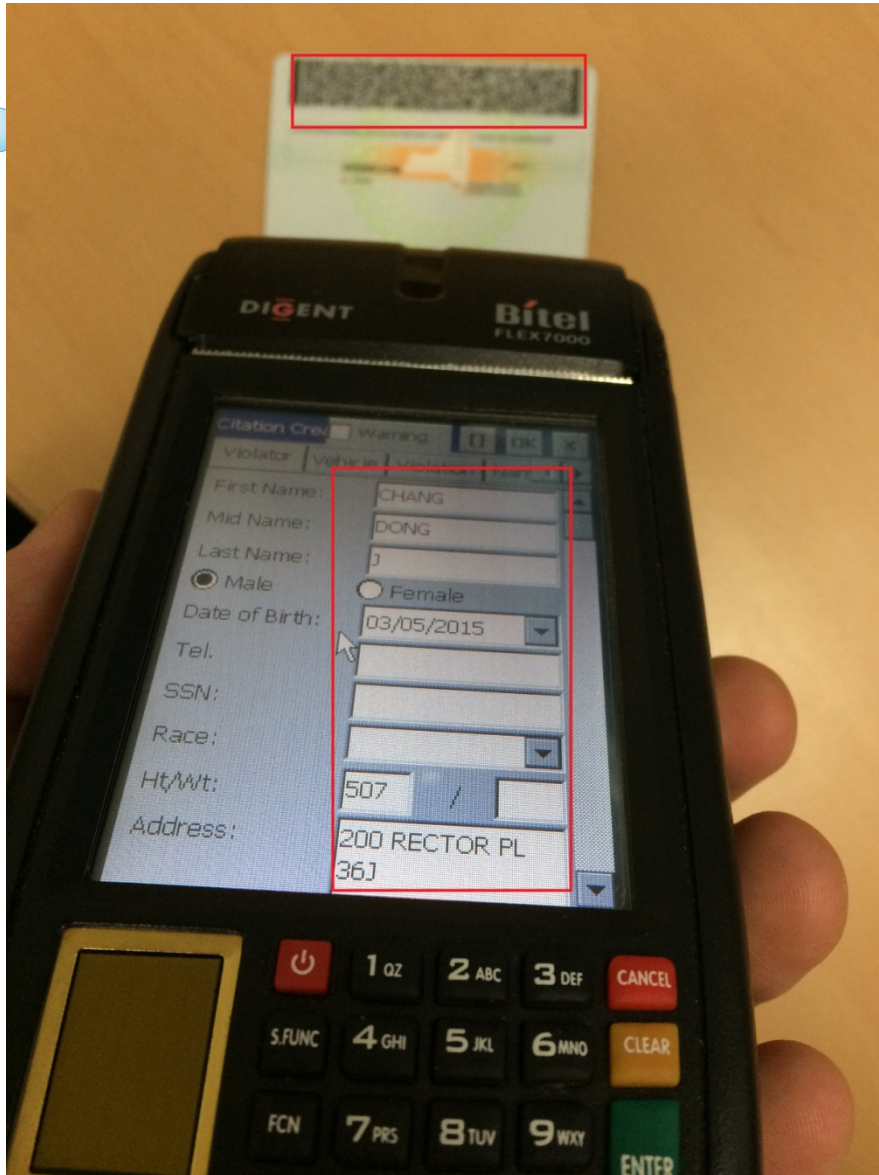
4. Press Button [Traffic & Warning]



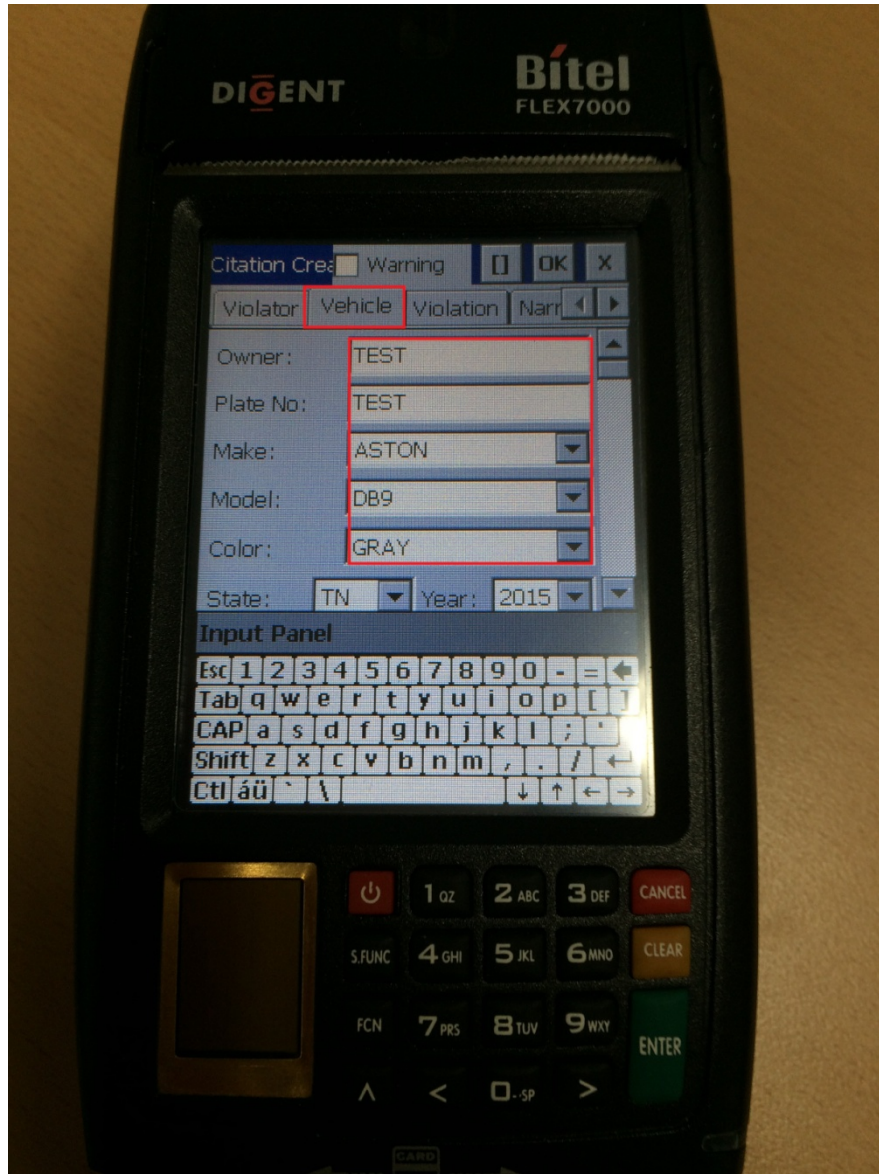
5. Press the button on the left side of the device for automatic input about the info. of automatic violator



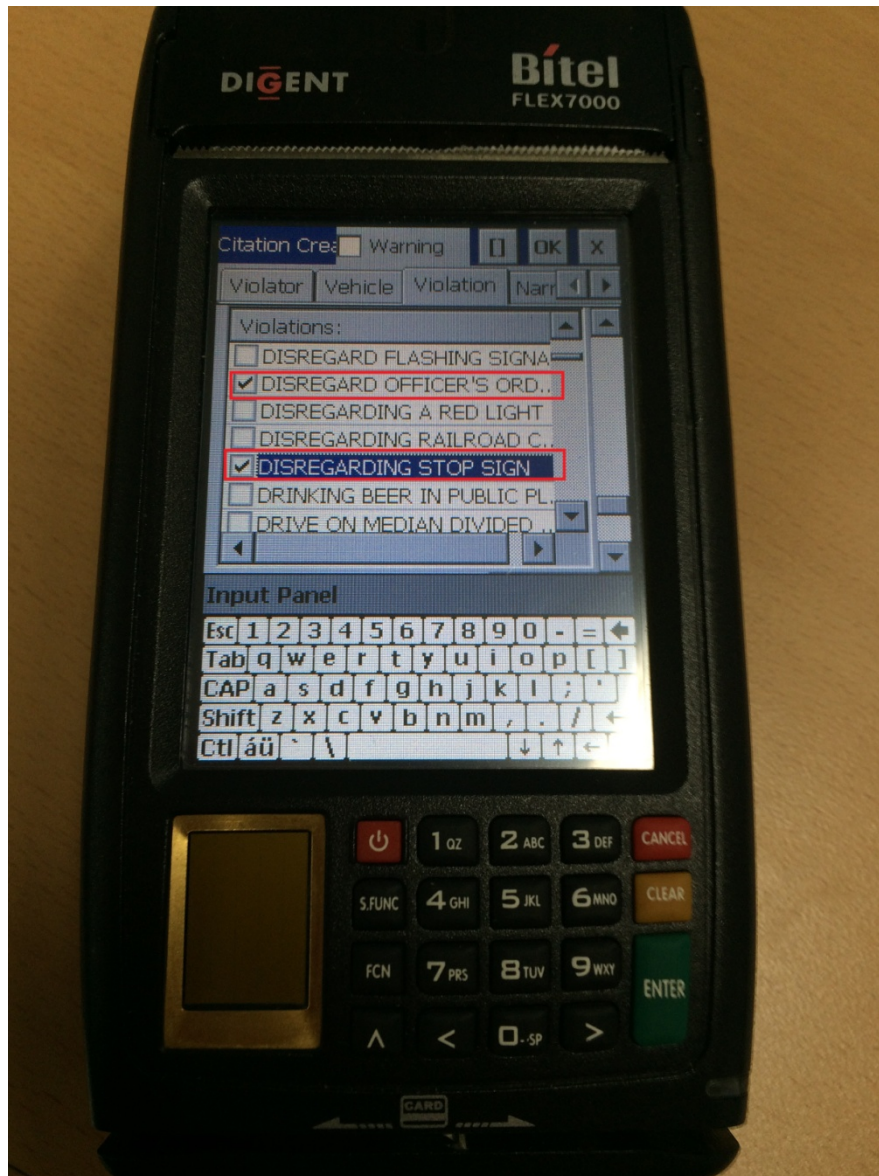
6. Press Button [Scan Barcode]



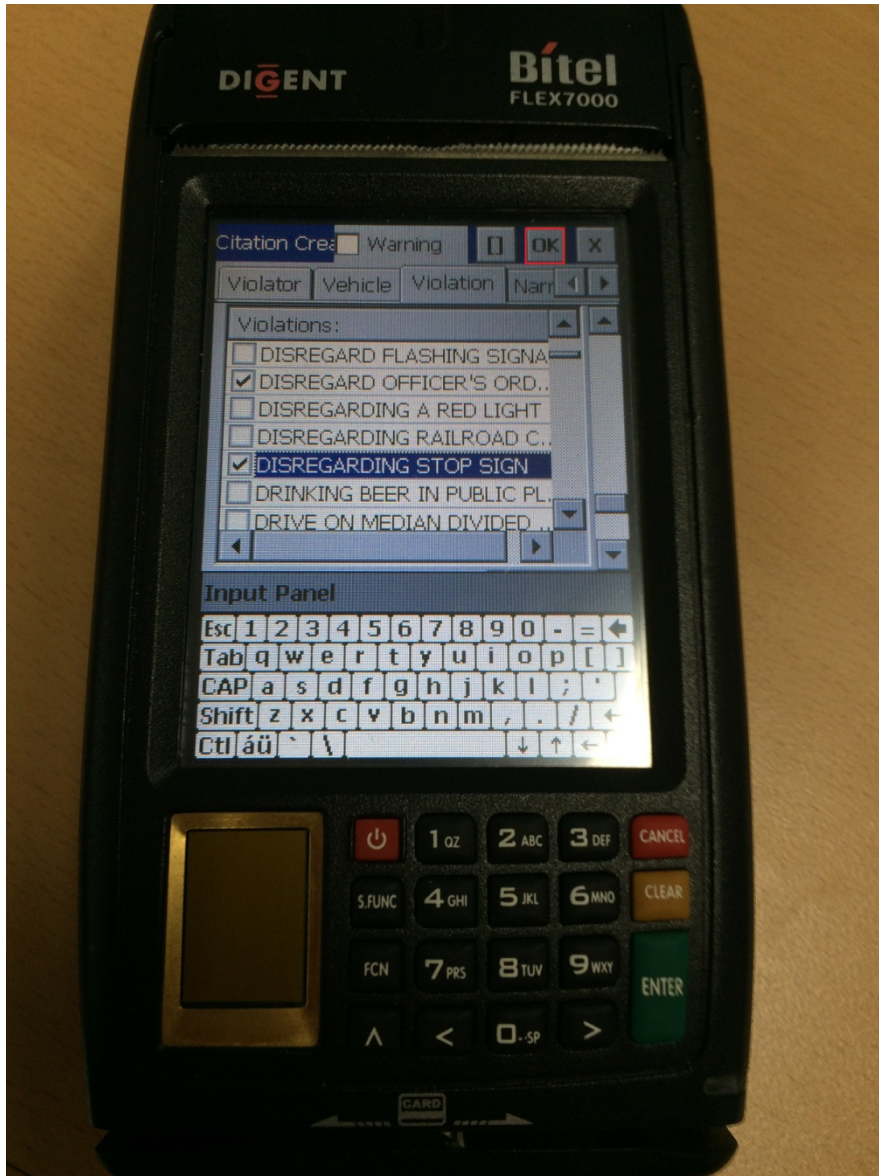
7. The violator's info. Is shown by previous step



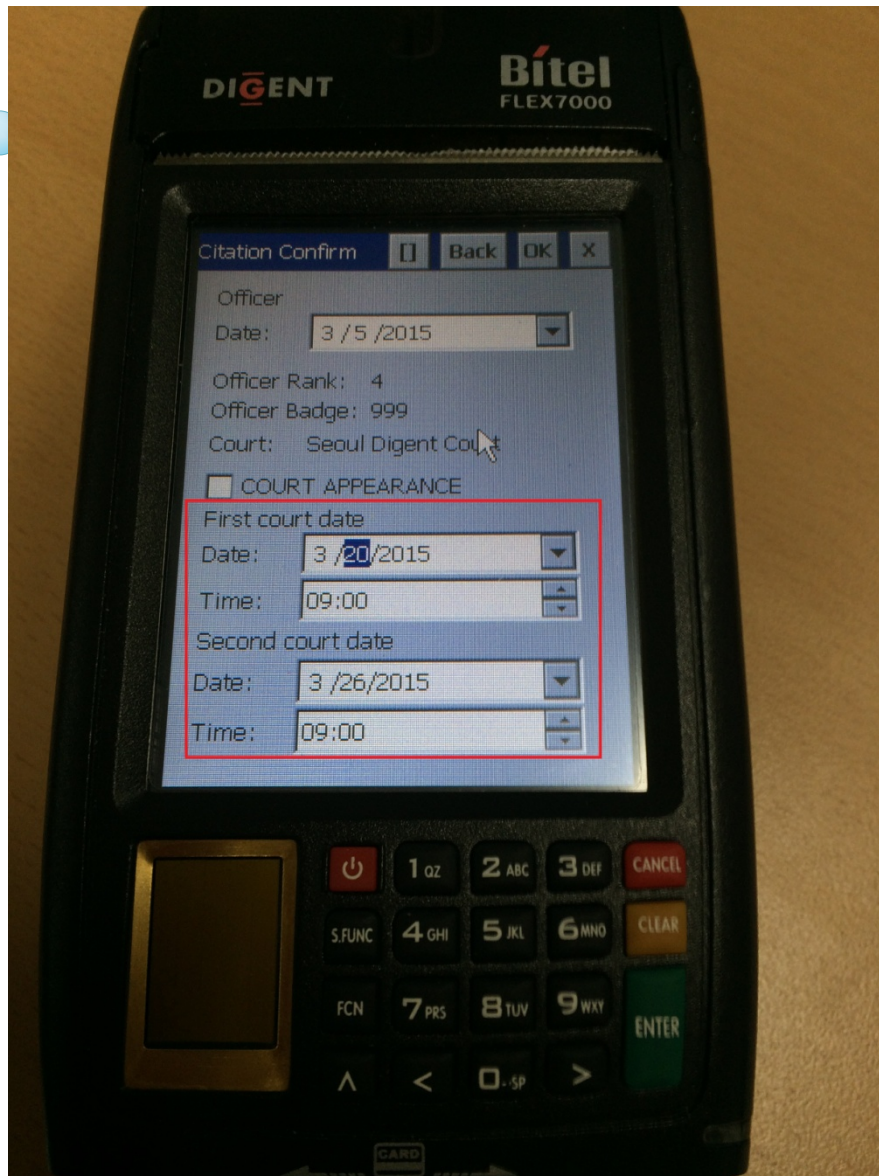
8. Input Vehicle info.



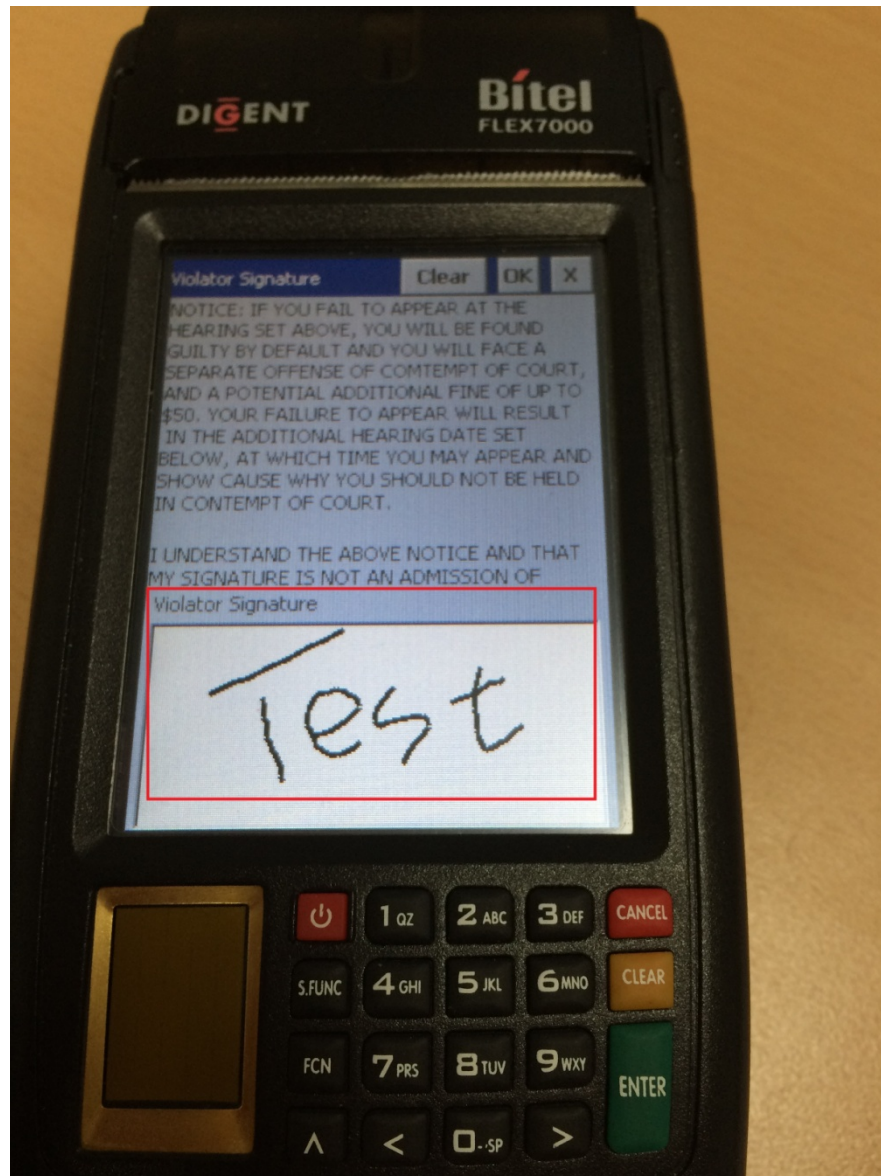
9. Check Violation(s) which violator infringed traffic law



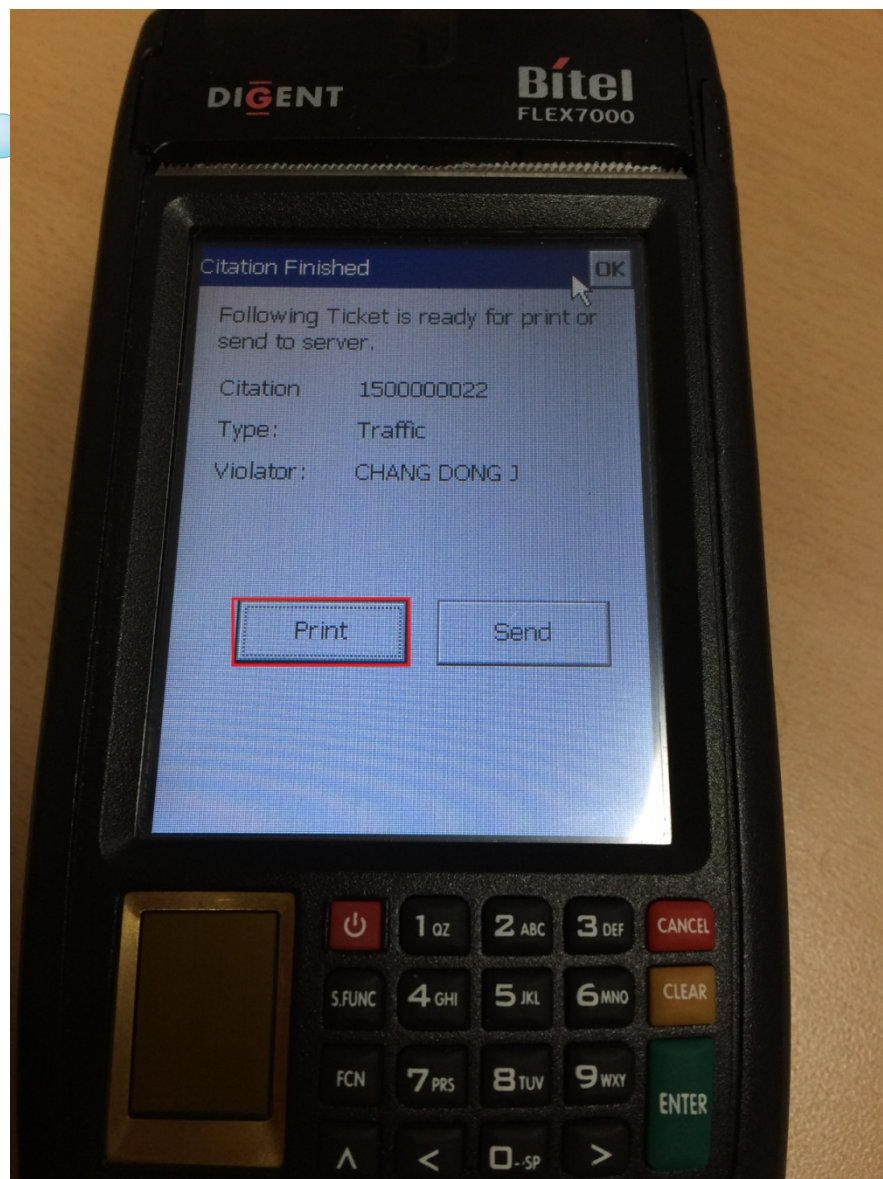

11. Input first and second court date ; and then, press Button [OK]



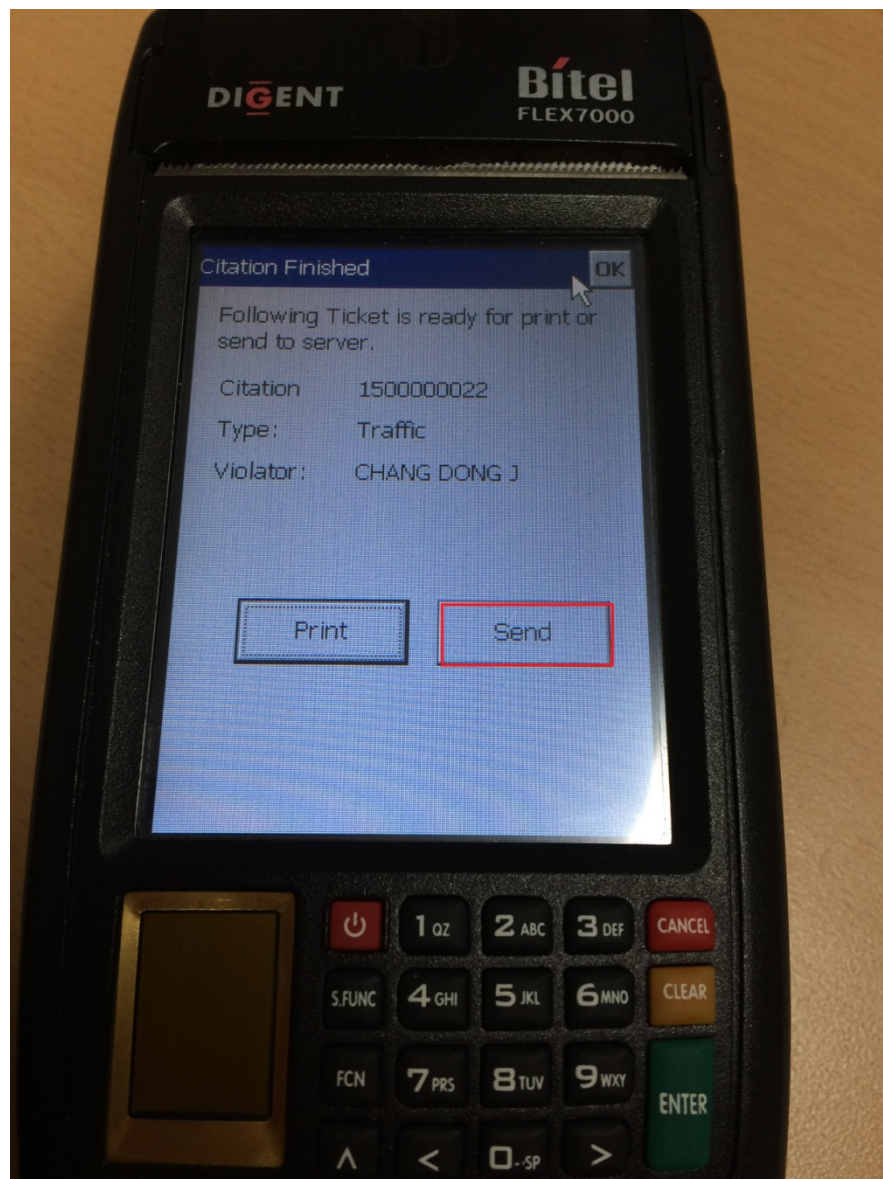
12. Write signature of violator ; and then, press Button [OK]
